Please note that, in compliance with the principles of lawfulness, purpose limitation and data minimisation, pursuant to art. 5 of G.D.P.R. 2016/679, subject to your free and explicit consent expressed in the annex to this information notice, your personal data will be kept for the period of time necessary to achieve the purposes for which they are collected and processed and in any case not beyond the terms established by the relevant tax, labour and social security regulations and by the Civil Code, and for a further ten years.

d) Scope of communication and dissemination

- Cancellation (art. 17 EU Regulation No. 2016/679);
- Limitation (art. 18 EU Regulation No. 2016/679);
- Portability, understood as the right to obtain from the data controller the data in a structured, commonly used and machine-readable format for transmission to another data controller without hindrance (Art. 20 EU Regulation No. 2016/679);
- Objection to the processing (Art. 21 EU Regulation No. 2016/679);
